TENNIS COURT HIRE:

The tennis courts are managed by Virginia State School. Please contact <u>tenniscourthire@virginiass.eq.edu.au</u> with any queries. The booking system can be found at <u>https://vss.tennisbcs2.com.au/</u> and contains information relating to availability, bookings and payments.

Virginia State School offers two tennis courts for hire on weekdays after 6:00pm and on weekends and public holidays. The tennis courts are located on Jefferis Street and are hard surface. Street parking is available.

Bookings are available at the following times:

- 6:00pm to 9:00pm on school days
- 7:00am to 9:00pm on weekends and public holidays

Fees are as follows:

• \$15.00 per hour per court

All bookings, pricing information, availability information and codes for access to the security keypad are done via the online booking system https://vss.tennisbcs2.com.au/. For enquiries outside of these key areas, please email tenniscourthire@virginiass.eq.edu.au.

Please always lock the gate when you have finished. Court lighting will turn off automatically 5 minutes after the end of your booking.

TERMS AND CONDITIONS OF USE:

All persons hiring or using the tennis courts at Virginia State School shall abide by the following terms and conditions of use:

- 1. Weather if you can't play due to heavy rain, please email <u>tenniscourthire@virginiass.eq.edu.au</u> within 24 hours of your booking time to arrange a new date/time for your booking, or request a refund via PayPal.
- 2. The venue and the equipment shall only be used on the date and between the times specified in your booking, and for the number of courts booked.
- 3. Non-marking footwear shall be worn at all times.
- 4. You are responsible for locking the facilities when you leave the premises.
- 5. Players and guests shall not cause a nuisance, or interfere with the reasonable peace, comfort, or privacy of other users of the premises or neighbours of the premises, particularly when playing late at night.
- 6. Facilities cannot be used for any purpose that will cause dissent in the community.
- 7. An adult must be responsible for children under the age of 18 using the facilities.
- 8. Dogs, drugs, alcohol, vaping and smoking are prohibited on school grounds and buildings (the tennis courts are on school grounds).
- 9. Players and guests shall not remove any fixture or fitting of the venue.
- 10. Organisations or individuals using these facilities shall be responsible in usage and protect property from damage.
- 11. Players and guests shall not use the premises for any illegal or objectionable purpose (as determined by the school).
- 12. Players and guests shall ensure that the courts remain clean and tidy after use. Please remove all rubbish items.
- 13. Virginia State School reserves the right to cancel a booking for guests that are not deemed financially current.
